Orgnization Briefing

Environmental Protection Agency in December 31, 1989. FECO was official approved as a nonprofit public organization attached to Chinese government by the State Council of China in 1997. Attached to and under the supervision of State Environmental Protection Administration of China, FECO has been committed to the foreign economic cooperation in the field of environmental protection for 16 years. The function role and responsibilities of FECO include the development, implementation and management of environmental protection projects which are sponsored and/or supported by the capital of international finance institutes, multilateral funds/facilities for compliance of international conventions and protocols in environmental protection and bilateral assistance funds (international development assistance funds). FECO has successfully introduced more than one billion US dollars for the environmental protection projects in China in the past 16 years.

FECO has been working in the field of CDM since 2002. The employees of FECO started research and development of CDM projects quite early in China. FECO successfully organized national and international workshops and seminars to promote the CDM project development in 2004. So far, two CDM projects which were promoted by FECO have been registered at CDM EB with the annual emission reduction of roughly 19 million tCO2e, they are Project for GHG Emission Reduction by Thermal Oxidation of HFC23 in Jiangsu Meilan Chemical CO. Ltd., Jiangsu Province, China and Project for HFC23 Decomposition at Changshu 3F Zhonghao New Chemical Materials Co. Ltd, Changshu, Jiangsu Province, China. FECO is facilitating more CDM projects that either has been approved by the Chinese DNA or being applied to EB for registration. The total emission reduction of the pipeline CDM projects fostered by FECO almost reach 30 million tCO2e each year of the crediting period.
